- Contraction of the second Abortion-derived cell lines used in vaccine development, production & testing (PER.C6 fetal cell line)
 - Emergency Use Authorization: <u>Feb. 27, 2021</u>
 - Clinical trials scheduled to end: Feb. 2, 2024
 - Mass vaccination for <u>3 years **before**</u> phase 1/2 clinical trials end
 - Vaccine technology: Viral vector-based • No claim to "protect you" (keep you from getting COVID-19)
 - No claim to "protect others" (prevent transmission of COVID-19)

 - Can't sue company for injury or death. PREP Act of 2005 protects companies from liability & removes accountability.
 - 95% effective? Disputed by scientists who say using all trial data (not just cherry picked data) lowers efficacy to just 19%-29%.
 - Risk of <u>getting sicker or dying because of vaccine</u> (called pathogenic priming or antibody dependent enhancement).
 - Pregnant & breastfeeding? Not proven safe (no clinical trial data yet), but VAERS data shows **720 miscarriages** so far.
